This agreement for photography services is entered into by the person(s) described on page 1, hereinafter referred to as "Client", and "Adam Brown" hereinafter referred to as "Photographer".

DESCRIPTION OF SERVICES

Photographer will provide high quality photographic services for the event(s) described on page 1. Unless otherwise noted, we will provide one professional photographer to take photographs using digital camera equipment, producing "Digital Images" in high-resolution .JPG format. In addition to the primary photographer assigned, Photographer may use additional photographers and/or assistants at its discretion. Unless otherwise agreed upon, the Digital Images will be delivered to the Client electronically over the Internet (Internet Photo Gallery) and via USB drive (Digital Photo Album). The Internet Photo Gallery will be online for six (6) months and will be removed at the discretion of Photographer.

COOPERATION & AVAILABILITY

The parties agree to cheerful cooperation for the best possible results. In order to help achieve the best results possible at large events, either the Client or their designee must point out individuals/groups that are important to have photographed. It is the Client's responsibility to ensure that key individuals are on time, available, and prepared to be photographed.

DESIRED SCENES

The Client will provide Photographer with a list of suggested photographs that they desire in advance. While every attempt is made to accommodate the Client's desired list of photographs and create the best images possible, no particular image is guaranteed. Photographer is equipped to handle most low-light situations. In situations where flash photography is prohibited or is deemed to be unsafe, the Client agrees to accept the Digital Images as-is, given the technical limitations of low-light photography.

COPYRIGHT, LICENSE TO USE, AND MODEL RELEASE

It is understood that Photographer owns the copyright to all of the Digital Images and reserves the right to use them for display, publication, advertising or other purposes. Upon receipt of final payment, the Client is granted a Non-Exclusive Unlimited License to use the Digital Images for their own non-commercial purposes, such as printing, electronic messaging, exchange with friends and relatives, or display on the Internet. The Clients grant Photographer the irrevocable and unlimited consent to use the photographs of the Client for editorial, competition, advertising and any other purpose and in any manner, to alter the photographs without restriction; and to copyright the images. The Clients hereby release Photographer from all liability and claims in connection with the images. No Digital Images will be provided to the Client until full payment has been made.

DEPOSIT, RESERVATION AND SCHEDULING

A non-refundable retainer totaling 50% of the agreed upon amount is due upon signature of this agreement. The balance is due the day of the event. Any overtime fees approved verbally by the Client during the event are due upon completion of the event. Upon signature and receipt of the deposit, Photographer will reserve the specified date and time for the event. All deposits are non-refundable even if the date has changed or the event is cancelled for any reason.

LIMITATION OF LIABILITY

Although great care will be taken with the Digital Images, this contract limits the entire liability for any claim, loss, injury or failure to deliver Digital Images to the return of any fees paid by the Client under this contract. In the unlikely event of personal illness or other circumstances beyond the control of Photographer, an attempt will be made to procure the services of another professional photographer to fulfill the obligations of Photographer. Photographer is not responsible or liable for any other damages beyond the amount of this contract. Client agrees to indemnify, defend and hold Photographer and their representatives, agents, contractors, employees, successors and assigns, harmless for any and all liabilities, damages, claims, suits, judgments, costs, fees and expenses that arise as a result of or in connection with the services provided.

Any changes to this agreement must be made in writing and signed by all the parties. This agreement constitutes the entire understanding of the parties and is governed by the laws of the State of California.

By signing this contract, Photographer and the Client agree to all of the terms and conditions stated in this contract.
